### Living in the Wider World - Diverse Britain

PSHE and Citizenship | UKS2 | Planning Overview

#### **About the Topic**

This unit is inspired by the idea that Britain represents a wide range of faiths and ethnicities and that the structures within it are there to support all. It aims to enable the children to identify how they can make a positive contribution to the community. In this unit, children learn about the law and the consequences of not respecting it. They will also learn about the workings of local and national government and the role of charities and voluntary groups in British society.



#### **Home Learning**

**Local Government:** In this activity, the children think about a local issue which is important to them. They then write a letter to their local MP explaining their thoughts.

Making a Difference: In this activity, the children choose a charity which they feel passionate about and design a poster to raise awareness for this charity.



#### Wider Learning:

Why not arrange a school trip to the <u>Houses of Parliament</u>? If this is not possible, arrange a visit from your local MP to discuss their job and how the children can become involved in local government.

- identify how they can make a positive difference to their community and country.
